MNH Indicators for Narsingdi

SI	Indicators	Status (Yes, No, or Partial)
01	Provide ANC services according to national guideline	
02	Women attending for ANC in the health facility are taken history, physical examination and minimum basic investigations done and are provided with supplements according to SOP	
03	Women attending for labor in health facility are fully assessed as per SOP without delay by a skilled provider	
04	Women who gave birth in the health facility are provided with options for pain relief during labor and child birth	
05	Women who give birth in the health facility receive oxytocin within 1 min of birth of the baby	
06	Newborns delivered in health facility are assessed and provided immediate and essential care according to national guideline	
07	Newborns who did not breath spontaneously at birth are given resuscitation with bag and mask	
08	Women in PNC ward in the health facility are assessed according to SOP during 1st PNC checkup	
09	Newborns born in the health facility receive 1 st PNC checkup within 24 hours	
10	Women with pre-eclampsia or eclampsia in the health facility receive full dose of magnesium sulphate	
11	Women with PPH in health facility are managed according to national guideline	
12	Women with prolonged/obstructed labor who gave birth by CS receive appropriate intervention according to national guideline	
13	Mothers with preterm labor (between 24 and 34 weeks of gestation) receive at least one dose of antenatal corticosteroid in the health facility	
14	LBW/preterm babies born in health facility with a birth weight ≤ 2000 g receive KMC according to national guideline	
15	Newborn stabilization unit and SCANUs are functioning for managing the sick newborn according to national guideline	
16	Facility comply standard hand washing practice and waste disposal during service delivery	
17	Facility maintains standard medical records are for maternal and newborn care services	
18	Facility implement MPDSR according to national guidelines

19	Pregnant and postnatal mothers referred to higher facility without delay, and following the completed standardized referral form according to national guideline	
20	Sick, preterm or small newborns who could not be managed at the health facility are transferred to an appropriate level of facility without delay, and following completed standardized referral form according to national guideline	
21	Facilities maintaining effective communication with referred facilities on referred clients	
22	Women discharged from the labor and child birth area of the facility receive written and verbal information and counseling (facility wise)	
23	Health education sessions are held in the health facility at ANC/PNC corner using standard IEC materials and job aids	
24	Facility provides privacy and confidentiality during ANC, Labor and childbirth	
25	Facility provides information regarding informed choices about the services	
26	Facility provides option of allowing a companion during labor	
27	Facility provides emotional support and appropriate counseling to patients during adverse event of labor.	
28	Facility ensures access to every women and newborn by skilled health provider at all times (24/7)	
29	Facility provides services to meet the requirement of women and newborn during labor child birth and early post natal period on the basis of skill mix	
30	Facility conducts regular QIC meeting and implementing action plan according to the decision of the meeting	
31	Facility ensures regular supply of essential medicine for providing MNH services	
32	Facility maintains patients' clinical records and service data according to guideline	
33	Submits reports on regular basis
